**1** SB 460—To establish five-member agricultural labor commission appointed by the Governor to study agricultural labor-management problems. Vote on passage, May 26.

**2** AB 241—To weaken egg standards. Vote on passage, June 16.

**3** SB 414—To provide loans from \$100 million state bond issue for both sales and low rent housing for elderly persons of low income. Vote on passage, May 26.

**4** SCA 10—To authorize 2100 million state bond issue for loans to provide both sale and rental housing for elderly persons of low income. Vote on adoption, May 26.

**5** SB 908—To emaculate eight-hour law for women, allowing ten hours of work per day and 34 hours in one week with time and a half beyond eight hours a day and 48 hours a week. Vote on passage, April 27.

**6** AB 673—To provide liberal coordination of state employee retirement system with federal social security program. Vote on conference report removing prior requirement of referendum vote among state employees. June 16.

**7** SB 97—To enact basic reforms in credentialing of teachers, reducing number of credentials and requiring greater subject matter knowledge in teacher training. Vote on passage, March 29.

**8** AB 327—To provide protections for all probationary teachers, with right to hearing on dismissal. Vote on passage, June 8.

**9** AB 1505—To declare state policy opposing discrimination against teachers based on age or marital status. Vote on passage, June 6.

**10** AB 350—To repeal agricultural exemption from 50 percent penalty provisions under workers' compensation regarding illness, employment of nurses under 16 years of age. Vote on motion to table a proposed \$3 per week increase in minimum and maximum weekly benefits for temporary disability. June 16.

**11** AB 889—Vote on adoption of amendments to provide \$2 increase per week in minimum and maximum benefit for temporary disability. June 16.
